Would each of the themes benefit from being divided into 'essential considerations' and 'important considerations', e.g.

1. Essential considerations before you plan your development

(For each theme there needs to be an emphasis on why a developer must consider this issue from the outset, e.g. EU Directives and national regulations etc).

(a) Water, pollution and infrastructure

- Managing the risk of flooding
- Managing surfact water
- Using water wisely
- Land affected by contamination (including the need to mention role of local authorities and controls they will impose)
- Preventing pollution
- Managing waste

(b) Wildlife and natural resources

- Woodlands and trees
- Statutory wildlife sites and biodiversity
- Protected wildlife species and licencing
- Sustainable management of soils

2. Important considerations to make your development sustainable

We suggest the following insert:

The Government's National Planning Policy Framework advises that the planning system must seek to achieve sustainable forms of development. This means that any planning application will be considered in terms of its sustainability, that is its long term impacts on society, the economy and the environment.

You should be aware that in order to be considered sustainable, you will need to demonstrate that your development proposals will make a significant contribution to the health and wellbeing of local residents, help to create places where people want to live, work and visit, and help the area to adapt to the effects of climate change.

The following themes could then be moved into this category:

- Environmental issues and opportunities for development
- Sustainable construction and design
- Delivering green infrastructure
- Access, recreation and leisure
- Landscape character
